**1984 Annual Meeting—Minneapolis, Minnesota (April 25-29).** General chairman of the 1984 meeting is Carol H. Krinsky, of New York University. Local co-chairmen will be Eileen Michels, College of St. Thomas and Tom Martinson of Ellerbe and Associates, Inc.

New York, has been awarded to Kim E. Lovejoy, graduate student in the Preservation Studies Program at Boston University.

The Rosann S. Berry Annual Meeting Fellowship is to be awarded each year to a student engaged in advanced graduate study to attend the annual meeting of the Society, and will be implemented for the first time at the Minneapolis meeting, April 25-29, 1984. The Society will waive all fees and charges connected with the meeting itself for the recipient of the Fellowship, and in addition will provide reimbursement for travel, lodging and meals directly related to the meeting, up to a combined total of \$500.00. To be eligible, an applicant must:

- 1. Have been a member of SAH for at least one year prior to the meeting;
- Be currently engaged in advanced graduate study (i.e., normally beyond the Master's level) that involves some aspect of the **history** of architecture or of one of the fields closely allied to it (e.g., city planning, landscape architecture, decorative arts or historic preservation);

# Annual Business Meeting Phoenix Hilton Hotel Phoenix, Arizona April 8, 1983

The meeting was called to order by President Damie Stillman.

President's Report. Stillman welcomed members to the 36th annual meeting and thanked General Chairman Carol Krinsky and local co-chairmen Bernard M. Boyle and Robert Giebner. Stillman also thanked Roger Schluntz, Dean of the School of Architecture, Arizona State University, James Ballinger, Director, Phoenix Art Museum, the Phoenix Magazine, tour leaders and volunteers who assisted in sessions and with registration. The Executive Secretary and SAH staff were also thanked. In his general remarks, President Stillman named several new and exciting Society projects: Buildings of the United States, the Translation Project and the Journal Index, soon available on line thru libraries and the SAH office. The recipient of the 1983 domestic tour scholarship was announced as Kim Lovejoy of Boston University. Stillman reported on a letter to the Honorable Thomas P. O'Neill, Speaker of the House, indicating Society concern against radical and needless change in the most significant exterior portion of the Capitol. This letter was read into the record on March 16th, by Barbara Miller Lane.

**Treasurer's Report.** Treasurer Henderson reported the Endowment Fund figure of \$147,530, an increase of \$29,926 over 1982. The Rosann A. Berry Memorial Fund has reached \$8,608. The Society has been able to maintain a surplus due to the final payment of the NEH Grant (1983 portion was paid in 1982). Concentration on cost reduction and increasing revenue is essential to a successful financial year.

**Executive Secretary's Report.** Executive Secretary Olson announced the total meeting registration of 330. Other figures reported were 55 new members since January, 1983 and a total membership of 4,281.

**First Vice-President's Report.** Carol Krinsky reported that arrangements for the tour to Finland, July 23-August 12, were in place and that a few places on the tour remained. Paul David Pearson, School of Architecture, City University of New York, and scholars in Finland will lead the tour which begins in Helsinki. August 24-28, SAH will tour western New York state. Jean France, of Pittsford, New York, is leading the group in the Rochester area. Frank Kowsky, State University College at Buffalo, will conduct the Buffalo portion of the tour. The 1984 annual meeting is scheduled for Minneapolis, April 25-29. The facilities of the newly constructed Amfac Hotel will be used.

Second Vice-President's Report. Osmund Overby announced sites and dates of future meetings and tours. Annual Meetings: Pittsburgh, April 17-21, 1985; Washington, DC, April 9-13, 1986; San Francisco, April 22-26, 1987;

Note: It is difficult to calculate exact statistics for any given period, mainly because manuscripts now being published were accepted at an earlier date, other manuscripts are awaiting readers' reports, and others are currently being revised. A few indicators, however, may be detected: an increase in the number of articles submitted, an increase in the number of articles published, an increase in articles on American topics, and a decrease in the number of book reviews.

Chicago, April 13-17, 1988; Montreal, April 12-16, 1989 and Charleston in 1990. Domestic Tours: Mackinac Island, August 15-19, 1984; Orlando, January 9-13, 1985; Providence, August 21-25, 1985 and southern Indiana, October 15-19, 1986. Foreign tours are being planned for Mexico, June 17-July 8, 1984 and to Yugoslavia in 1985. Overby requested recommendations of sites for Society meetings and tours. Overby announced his recent election as Secretary of the HABS Foundation, a group to raise funds for support of HABS projects.

Secretary's Report. Eileen Michels reported that SAH Chapters number 24. 1982 saw the inclusion of a new theme chapter, Census of Stained Glass in America. Fourteen chapter representatives attended a recent meeting where discussion was held on problems common to all chapters and on development of programs to continue interest in given communities. Michels encouraged Chapters to stress national membership.

Journal Editor's Report. Editor Naomi Miller thanked Book Review Editor Richard Betts and informed attending members that the December issue of *JSAH* has been mailed. Copy for March and May issues is at the press.

**Newsletter Editor's Report.** Editor Geraldine Fowle thanked assistant *Newsletter* Editor Tom Ridington, and Publications Editor, Judith Holliday. The *Newsletter* will carry the Placement Notices as part of each issue. Mailing of the *Newsletter* from the Philadelphia office began with the December, 1982 issue and will result in a savings of close to \$1,200 per year.

**Preservation Committee.** Stillman, in the absence of Longstreth, told members of the mass involvement of SAH preservation interest and their presentations at various levels. Stillman, on behalf of the Society and the Preserva-

tion Committee, recently wrote a letter to the Speaker of the House in support of strong opposition to the proposed replacement of the central portion of the West Front of the U. S. Capitol by a westward extension.

**Education Committee.** Dora Wiebenson announced the formulation of a reviewing system for programs in Architectural History. Dependent on approval of the Board, the program would help to develop a system by which Architectural History can be taught in very different situations. As sponsor of such a program, SAH will have a universally recognized position of leadership and guidance in the field of architectural history. The Committee will concentrate on procedure with emphasis on ways to strengthen all programs of Architectural History.

Membership Committee. Theresa Conway asked members to encourage colleagues and friends to renew membership. The committee is searching for state coordinators and would appreciate names of persons willing to serve in this important capacity.

Finance/Development Committee. In the absence of Chairman Halpin, Stillman announced that the committee requests continuing support for the program of the Society which urges members to make bequests to SAH in their wills. The committee further encourages members to seek for new corporate membership, especially from corporations interested in and having concern for the built environment.

Ad Hoc Translation Committee. Henry Millon announced interest from the Translation section of NEA of having SAH apply for a grant to assist with the programs of translating articles of Architectural History. Millon indicated possible difficulty in locating the right person to serve as editor for this project. Preliminary plans include publication of 20 volumes over a period of 10 years.

**Buildings of the United States.** Editor in Chief, Adolf Placzek reported on recent activity of the Editorial Board and the project. A grant proposal to find the prototype of the series was recently submitted to NEH. Result due in August or September. The committee requests suggestions for funding. Planned guides include Iowa, Tom Martinson and David Gebhard; Rhode Island, William Jordy; Virginia, Dell Upton and Edward Chappell; The Buildings of Oregon, Portland Chapter of AIA's Historic Resource Committee, and The Buildings of North Carolina, Catherine Bishir. The Editorial Board hopes to have the services of a managing editor and to establish an office.

Ad Hoc Journal Committee Report. Damie Stillman advised that the purpose of the committee has been to review all aspects of the *Journal* and its production. The need of maintaining quality and having a reduction in cost has been a prime concern. The Executive Committee will meet on April 9th to take up recent findings and the recommendations of the committee.

**Old Business.** At the 1982 Annual Meeting a motion was made and approved that SAH register support for the equal rights amendment and that the results be reported on at the 1983 meeting. Due to defeat of passage of ERA, no decisive action will be taken at this time. The Board is in the process of discussing the implications of taking a stand on political issues that have no architectural ramifications.

There was no new business.

Nominating Committee. Elizabeth MacDougall, member of the 1982 Nominating Committee named the rest of the committee, David Van Zanten, Chairman, John C. Ferguson, Robert W. Jorgensen, Harriette Von Breton. The 1983 slate of officers and Board nominees was read as follows: Damie Stillman, President; Carol Krinsky, First Vice-President; Osmund Overby, Second Vice-President; Eileen Michels, Secretary; and Paul Henderson, Treasurer. Directors nominated were Mosette G. Broderick, Robert Bruegmann, Teresa Conway, William Drake, Allan Greenberg, Harriette Von Breton, and John Zukowsky. Secretary Michels called for a vote. Unanimous in favor with addition of proxies (218).

Stillman congratulated all new Board members and warmly thanked George Ehrlich, James Halpin, Earl Layman, Victoria Newhouse, Adolf Placzek, Janann Strand and Dora Wiebenson for their three years of dedicated service to SAH.

The Nominating Committee for 1983 will be chaired by Margaret Henderson Floyd and will have Mirza Dickel, Michael Fazio, Hyman Myers, and David Van Zanten as members.

In recognition of the Historic American Buildings Survey's 50th anniversary, SAH presented the following resolution, read by President Stillman:

Whereas the National Park Service just fifty years ago brought forth the Historic American Buildings Survey and whereas the Survey has become for architectural historians one of the great treasures of this country, responsive to the needs of scholars and authors, readily available to all and a palpable factor in the education of each rising generation of students. Now, therefore, be it resolved: That the President of the American Institute of Architects and the Library of Congress be reminded of our warm, continued interest and that the Director of the National Park Service be reassured of our support and the hope that the next fifty years will witness the continued and even more vigorous growth of the Historic American Buildings Survey.

Mary Lou Grier, Deputy Director of the National Park Service accepted and thanked SAH for support. Grier introduced HABS personnel–Robert Kapsch, Ken Anderson, Alicia Stamm, Sally Tompkins and John Burns.

Founders' Award. The Founders' Award selection committee, chaired by Marian Donnelly, with Walter Leedy, Jr., and Stanford Anderson as members of the committee, awarded the 1982 Founders' Award to Richard J. Tuttle for his article "Against Fortifications: The Defense of Renaissance Bologna" which appeared in the October, 1982 issue of the *Journal*. In addition, Tuttle received the first annual Ann Van Zanten Memorial Medal. Donnelly read the following citation:

The Society of Architectural Historians awards to Richard J. Tuttle its Founders' Award for his article "Against Fortifications: The Defense of Renaissance Bologna," adjudged the best article appearing in the *Journal of the Society of Architectural Historians* in 1982 by a young scholar. Mr. Tuttle, the Founders' Award Committee commends you for your meticulous investigation of the historical and documentary evidence for the efforts to refortify the city of Bologna in the 16th century. You have been able to show the complex political and economic reasons for the failure of these efforts. In so doing you remind us that not only positive but also negative decisions have profound consequences for architectural and urban development as well as presenting challenging opportunities for historical studies.

Alice Davis Hitchcock Book Award. The 1982 Alice Davis Hitchcock Book Award went to Robert Grant Irving for his book *Indian Summer: Lutyens, Baker and Imperial Delhi*, published by Yale University Press. The citation was read by committee chairman Spiro Kostof.


This beautifully written and handsomely presented book provides a meticulous, comprehensive account of New Delhi, from the imperial vision which conceived it, through the maze of bureaucratic and professional activity which brought it into being, to its eventual achievement. Professor Irving skillfully merges political and architectural history to describe this major episode of twentieth-century architecture and urban planning, and analyzes with discerning fairness the clashing approaches to design of Edwin Lutyens and Herbert Baker against the broader canvas of a sunset enterprise of the British empire.

Other members of the committee were William Jordy and Barbara Stafford.

The next annual meeting will be held at the Amfac Hotel in Minneapolis, April 25-29, 1984.

The meeting was adjourned at 2:30 p.m.




SAH Alice Davis Hitchcock Book Award Winner Robert Grant Irving

## HITCHCOCK AWARD

At its thirty-sixth annual meeting, the Society presented Robert Grant Irving with its highest honor, the Alice Davis Hitchcock Book Award, recognizing his book, *Indian Summer: Luytens, Baker, and Imperial Delhi,* as the most distinguished work of scholarship in the history of architecture by a North American scholar during the two preceding years. The book tells the story of the conception and creation of New Delhi, the grandest venture in planning and architecture in the history of the British Empire.

Irving holds degrees in history and the history of architecture from Yale and Balliol College, Oxford. His varied career includes a Fulbright Scholarship in England and research fellowships in New Delhi, Africa and Cambridge. He has taught at the University of Virginia and is currently an Associate Fellow of Berkeley College at Yale, and is engaged on research for a biography of Sir Herbert Baker, major architect for the British overseas empire.



SAH Founders' Award Winner Richard J. Tuttle

## FOUNDERS' AWARD

The Founders' Award, made for the best article on the history of architecture published each year in the Society's *Journal* by a young scholar, was presented this year to Richard J. Tuttle for his article, "Against Fortifications: The Defense of Renaissance Bologna," which appeared in the October 1982 SAH *Journal*. At the presentation ceremony in Phoenix, Tuttle was given the first annual Ann Van Zanten Memorial Medal.

Tuttle received his Ph.D at Stanford University in 1976 and is now a member of the Department, Graduate Faculty at Newcomb College, Tulane University. He spent four years on the staff of the German Bibliotheca Hertziana in Rome prior to receiving his doctorate and has authored numerous articles. Currently he is completing a monograph on the Fountain of Neptune in Bologna.
